Brie motions to approve last meeting minutes

Tara seconds Vote approved – 13 yes Five abstained

Volunteers

We have about as many now as we did last year at this time, but this year we are needing more volunteers.

We especially need more gate volunteers.

Gretchen and Shelsea talked about closing positions on the signup form that aren't essential so other roles are filled first.

All volunteers should have email stating shift time, discount codes All volunteers will get reminder emails closer to the event Last day to sign up to volunteer is October 1 Last day to purchase volunteer tickets is October 1 Because we are not mailing tickets this year, sales can be extended to the Monday before the event

We will change ticket date to October 10

We will change volunteer signup to October 5

Bob and Lea will discuss whether ticket sales tiers need to change

Steve says all leads need to fill out the FML form This allows leads to get their ticket codes

Performers and selected volunteers will be informed of selection dates today They will be notified before October 5

Permitting

We are able to close Walnut

We can close one sidewalk, but must leave the other open We can close part of the sidewalk by Fusion to allow entrance into the parking lot

Fire requirements are same as past years, but are very strict Anyone bringing fire art must have paperwork to Brie by September 30

Brie will email fire requirements to Robert and January for their art car

Ticketing

Sales dates are extended, so tier two tickets may extend 10 days Tier two (\$20) will now end on 9/17 Tier three (\$25) will now end on 9/27 Tier four (\$30) until 10/10

Sales are very low, we have 1600 more to sell

If we have door sales, they will only be by credit card Lea and Brie will talk about implementing cc sales

Venue

Exdo requires, and will be doing bag searches (a.k.a. Stadium Checks) – no drinks allowed in Empty water bottles OK No food No weapons, pepper spray No drugs, including marijuana

Budget requests

Brie needs more funds for extra fencing

Bob motions to add \$200 to gifting budget for stickers

(swag = \$180) (extreme volunteers = \$20)

Joy seconds Unanimous vote to approve

Brie motions to add \$1850 to Porta potty budget

Steve seconds Unanimous vote to approve

Grant motions to add \$450 to budget to bring Deep Cycle as art car/DJ stage

Keli seconds Unanimous vote to approve (total sound budget is now \$1050) Discussion: Sound/DJs were approached by Deep Cycle art car This is currently our only official option for an outdoor stage Two art cars have applied for art grants at DeCOmp: Deep Cycle and G Ride Both are able to serve as a DJ booth Deep Cycle has built-in sound, but we won't need to use it Can set up a table over the fuselage of the plane for DJs Will have fog machines If Sound budget is increased, Deep Cycle does not need the art grant they applied for and will withdraw their request Deep Cycle has a generator that Sound can plug into Blower and exhaust are on top Other art cars can still come, they just won't be the outside stage DC will need six volunteers to help with set up/tear down Just a generator would have cost \$650 plus extra requirements

Need lead updates about volunteers

An announcement will go out to remind DJs that not everyone will get a slot, so if the want a guaranteed volunteer price ticket they should sign up for a volunteer shift outside of DJing

Performers

Has 21 signed up so far

Sign up deadline has been extended to 9/24, selections will immediately follow and will be announced on 9/27

Hot Cocoa would like to do a group performance; we have encouraged them to sign up for other volunteer shifts as well so as not to tap the performance volunteer allowance

Art Grant

18 people have applied to bring art/for art grants

Half of the people applying for art grants have elected to pay for a full price ticket Because of this all art volunteer tickets should be do-able Deadline for applications is 9/22 Checks will be distributed on 9/29 Art grant budget is \$6400

DJs

32 people have signed up so far Deadline to apply is 9/23 Names will be drawn on 9/29
